Life and Peace Institute Releases Bulletin on Horn of Africa

The Life and Peace Institute, a Member Organisation of Pax Christi International, issued its first 2012 issue of the Horn of Africa bulletin. The bulletin contains three analytical articles. Former guerrilla leader Ntaganda has a big impact on the situation in the northern region of Kivu. Pax Christi Flanders advocates that the European Union and the United Nations must support the Democratic Republic of Congo's government in expatriating the general to the International Criminal Court.

Pax Christi International Executive Member Visits Taiwan

Pax Christi Flanders on Economic Sanctions and Iran

An international military intervention in Iran needs to be prevented. Iran is urged to become a partner in the nuclear weapon free zone for the Middle East. A Report on European Union – Israel Relations

APRODEV, the Euro-Mediterranean Human Rights Network (EMHRN), the MEDEA Institute, and the European Movement Belgium held a public presentation of the new APRODEV-EMHRN report titled “EU-Israel Relations: Promoting and Ensuring Respect for International Law at the Midi de la Méditerranée”. The report, which was released on the 14th of February 2012, analyses different avenues for the European Union to promote Israel’s compliance with its obligations as an occupying power, and to ensure that its contractual relations with Israel are in full compliance with its own obligations under international law. Meeting on Current Issues in the Occupied Palestinian Territories

The Quaker Council for European Affairs, the Ecumenical Accompaniment Programme in Palestine and Israel, and the United Nations Office of the High Commissioner for Human Rights held a meeting on the 17th of February 2012 in Brussels on the issue of "Strengthening Protection and Promoting Accountability in the Occupied Palestinian Territories." World Week for Peace in Palestine Israel

Pax Christi International and several of its Member Organisations are involved in the annual World Week for Peace in Palestine and Israel. New resources are available in advance of this year's World Week for Peace in Palestine and Israel, an initiative of the Palestine Israel Ecumenical Forum of the World Council of Churches, to be observed from the 28th of May to the 3rd of June 2012. Seeking the Ways out of Violence in Syria

In its fifth Syria Alert policy brief, IKV Pax Christi recommends to focus on protecting civilians in Syria and on de-escalating the violence on the ground and in the region. The international community should specifically: (1) Provide technical, financial and moral support to the nonviolent forces that promote a democratic Syria for all its citizens; (2) Seek political engagement of all relevant actors, including China and Russia, in pressuring Damascus to allow entry to UN human rights observers and in promoting a political way out of the crisis; (3) Assess all possible non-military instruments to protect Syrian civilians and not

Join a music production next to the Wall in Bethlehem

From the 9th to the 16th of July 2012, Arab Educational Institute (AEI) will be in Bethlehem filming a production on the birth of Jesus. This production will be narrated and sung from a contemporary Palestinian viewpoint. The production will take place at the Wall Museum, which was developed by AEI's Sumud Story House in northern Bethlehem. The Wall Museum is large posters on stories of Palestinian women's resilience to restrictions and pressures in the Occupied Territories. In the course of the coming months, AEI will develop the details of the play in cooperation with creative international volunteers such as singers and instrumentalists. DISARMAMENT & DEMILITARISATION

Pax Christi UK: Ash Wednesday witness at the Ministry of Defence

The 22nd of February 2012 marks the beginning of Lent on Ash Wednesday, a time when Christians join together to face their own sinfulness and need of repentance. It is a time to turn away from those things which deny life and to turn things that are life-giving. For the 30th consecutive year, Christians will gather at the Ministry of Defence in London to challenge the United Kingdom government's on-going commitment to a nuclear defence policy. There are 22,000 nuclear weapons located on 111 sites in 14 countries. The United Kingdom alone has 225 nuclear weapons and the Royal Navy boasts a proud record of over 40 years of uninterrupted nuclear deterrence. At least one of the four Vanguard-class submarines is on patrol at all times. More information is available at www.paxchristi.org.uk. Colloquium on Nuclear Disarmament in France

Pax Christi France, the Justice and Peace Commission, the Diocese of the Army, and the Faculté des Sciences Sociales et Économiques (FASSE) are planning a colloquium on nuclear disarmament at the Institut Catholique in Paris, from the 16th to the 17th of March 2012. PrepCom 2015 NPT Review Conference

The Preparatory Committee for the 2015 Review Conference of the Parties to the Treaty on the Non-Proliferation of Nuclear Weapons takes place in Vienna from the 30th of April to the 11th of May 2012. On Eve of 4th PrepCom, the Belgian Parliament states Unanimous Support for a strong ATT

A few days before the start of the 4th and final Arms Trade Treaty PrepCom, the Belgian federal parliament called out for a strong Arms Trade Treaty. In a unanimously approved resolution the members of parliament urged the Belgian government to strive for the strongest possible ATT and to convince other states to join this pro-ATT position.

Pax Christi reacted positively on the news of the resolution: "Belgium has a tradition in supporting international disarmament initiatives. We're hoping that this resolution will guarantee the commitment of the Minister of Foreign Affairs and the diplomatic services as facilitators of a strong Arms Trade Treaty."

MP Dirk Van der Maelen, together with Pax Christi Flanders the initiator of the resolution, explains why he's convinced we need a strong and robust ATT: "We must link arms deliveries to conditions that promote human rights and development. A strong and enforceable treaty must supervise all light and conventional weapons. With a strict Arms Trade Treaty, you will succeed in sustainable poverty reduction." Arms Trade Treaty and Asia

Beth Begley, the delegate of Pax Christi International at the United Nations in New York, attended a workshop on Asia and Arms Trade Treaty on the 15th of February 2012. The event was organised by Binalakshmi Nepram from Control Arms Foundation India. A

representative of the Indian government, the Sri Lankan parliament, along with delegates from Norway, Germany, Australia, and many more countries missions attended.

Action Alert: Tell Congress to Maintain Military Spending Cuts

On the 3rd of February 2012, Pax Christi USA and the Maryknoll Office for Global Concerns called their membership for an action alert on military spending in the United States. Last year Congress made a deal to cut the deficit. Half the cuts were to come from domestic programs and half from military. Unfortunately, members of Congress are promoting possible legislation that will renege on this decision, allowing domestic program cuts to go through but reversing the cuts to the Pentagon's budget. The alert is based on information circulated by the New Priorities Network, of which Pax Christi USA is a member.

Another Defence System for Europe

In January 2012, Pax Christi Wallonie-Bruxelles issued a publication concerning possible alternatives for defence in Europe. They also are questioning the role of NATO in new strategic defence paradigm for Europe. More information is available in French [here](#).

Right to Peace

Pax Christi International supported a written statement submitted to the Human Rights Council Advisory Committee at its 8th session in February 2012. Experts were invited to consider further amendments to the text of "Right to Peace." These amendments include the recognition of minority groups and humankind as stakeholders of the right to peace. Food and Health

Pax Christi International has joined Caritas International and other NGOs on an oral and written statement on “Food and Health: A Life-Saving Combination for Adults and Children Living with HIV.” The statement concerns item three of the 19th session of the Human Rights Council. It will take place in Geneva in March 2012. All people should enjoy access to systems that contribute to health and nutritional security. These systems should take into account the special dietary needs of adults and children affected by severe illnesses, in particular, those living with HIV.
