Ex-combatants Project Considers Next Steps

Organisers of a project to help reintegrate former fighters gathered recently in the Great Lakes region of Africa to evaluate final project results and to plan the next phase. The evaluation session took place from the 23- 26^{May} 2012 at the Centre Spirituel Kiriri in, Bujumbura, Burundi. Since 2010, Pax Christi International and Pax Christi Flanders have joined together in supporting the formation of 'Listening Communities' to accompany ex-combatants as they transition back to civilian life. Over this period, the project has engaged more than 100 men and women in 10 locations. Coordination Meeting on Extractives in Colombia and Peru

On 28 June 2012, Martha Inés Romero, Latin America Regional Coordinator of Pax Christi International met with Marianne Moor, Colombia Coordinator of IKV Pax Christi Netherlands; Michel Uiterwaal, Advisor on Extractives, Human Rights and Conflict; and with Miguel Galvis, Colombia Local Coordinator. Martha Inés shared the Regional Plan and the project for 2012 of Pax Christi International. Marianne and colleagues presented the strategy for Colombia and their experience with extractives in Peru. The strategy provides useful information for the process Pax Christi International is developing on the issue on extractives, war and communities' rights.

On Extractive Companies in Peru

Pax Christi Peru has supported the statement from the Catholic Church and other social actors in which it denounces human rights violations in the Espinar Province. After weeks of civilian strike against extractives companies that have contaminated water and ignore communities' rights, there have been widespread abuses from state forces: murders, wounded people, arbitrary detentions etc. An agreement is expected amongst communities, national and local government and companies to establish a formal dialogue in which parties explain their positions and the common good will be above private interests. On Water Rights in Department of Cajamarca, Peru

Organizations and social movements in the Department of Cajamarca in Peru have conducted peaceful protests in defence of water rights that are threatened by the installation of the Conga mining project by Minera Yanacocha/Newmont Mining Co. On July 9, 2012, a letter/statement was delivered to President Ollanta Humala by human rights, social and environmental justice organisations including Pax Christi International. 2012 Teacher of Peace Award

Pax Christi USA has recognized the life and witness of Ruben Garcia, naming him the 2012 recipient of the Pax Christi USA Teacher of Peace Award. The first recipient of the award in 1978 was Dorothy Day, co-founder of the Catholic Worker movement. Pax Christi USA has since recognized some of the most significant U.S. Catholic activists for peace and justice of the past three decades, including actor Martin Sheen; poet and priest Daniel Berrigan, S.J.; and 'Dead Man Walking' author Sr. Helen Prejean, C.S.J. Ruben Garcia is one of the founders and the current director of Annunciation House in El Paso, Texas.

The op-ed states that there will be no DEUS EX MACHINA to save the two state solution: "Europe has created dangerous expectations by reinforcing Israel's belief that it can continue to expand settlements and effectively annex occupied territory without any real consequences. As long as European leaders do not send a strong signal - beyond statements - that violations of international humanitarian law and human rights are unacceptable, they are contributing to the degradation of the international legal order." Handover ATT Declarations and Petition to Ban Ki-moon

Control Arms Campaigners, Pax Christi International and other organisations are calling on political leaders to agree on a strong Arms Trade Treaty (ATT) in New York, with common standards for the import, export and transfer of conventional arms and ammunition. For the past few months around the world, campaigners, religious leaders, medical professionals and parliamentarians have been collecting signatures and support for a bullet proof ATT.

Strong Plea for Effective Rules to Regulate the Arms Trade

On 11 July 2012, Civil Society delegates were able to deliver a speech at the Diplomatic Conference for an Arms Trade Treaty in New York. One of the speakers was Jasmin Galace of IANSA and the IANSA Women's Network (PHILIANSA). Jasmin also spoke as a member of Pax Christi International in the Philippines and said the following:

"I am a member of Pax Christi International, and members of this faith-based organization from South Sudan to El Salvador, Haiti to Iraq, Mexico to the Philippines, the Democratic Republic of the Congo to the United States of America, have seen how conventional weapons have been used to commit human rights violations. Whether these weapons circulate during or in the wake of war and violent conflict; they are collected and used by violent gangs and organized crime; or their proliferation is driven primarily by lucrative profits, the cost in human life and misery is unconscionable. The specific impact on women and children is especially egregious, as is the diversion of resources needed to protect human life and human rights and the natural world."

Religious leaders say Arms Trade Treaty must regulate ammunition

Christian leaders representing organizations of some 90 percent of the world's two billion Christians have issued a joint appeal to the 194 governments currently negotiating the first global Arms Trade Treaty: Keep ammunition in the treaty. Proposals on the negotiating table would ban arms sales for genocide, war crimes and grave human rights violations. Almost all of the 194 states involved recognize that the arms

and ammunition most often used in these crimes must be included in the treaty.

Churches and their members witness the human costs of unlawful armed violence every day, as victims are brought to church hospitals and church graveyards in different parts of the world. In a joint statement issued on 20 July 2012 representatives of the World Council of Churches, World Evangelical Alliance, Pax Christi International and Caritas stated "The Arms Trade Treaty must regulate the ammunition that strikes them down".

A minority of countries including major powers insist that the treaty not regulate ammunition. "There is no way ammunition can be omitted from the long-overdue regulation of a trade that has brought such suffering and death to millions of people," the church leaders declared at the half-way point in sensitive, month-long UN treaty negotiations. Marie Dennis, Co-President of Pax Christi International is one of the signatories of the statement.

The moderator of the World Council of Churches Central Committee, the Rev. Dr Walter Altmann, is leading the ecumenical delegation at the [UN Conference on the Arms Trade Treaty](#) in New York. The WCC [campaign for a strong and effective Arms Trade Treaty](#) involves some 70 member churches and related organizations in 35 countries.

Breaking the Nuclear Chain

Breaking the Nuclear Chain is a new campaign to inform, motivate and activate people to prevent the looming humanitarian catastrophe represented by the nuclear chain – from uranium mining, to power, weapons and to nuclear waste. It is an initiative of the Global Partnership for the Prevention of Armed Conflict (GPPAC), IKV Pax Christi Netherlands and Peace Boat.

The modernization of nuclear weapons, the tragedy at Fukushima and the devastation at Jabiluka among other disasters are dreadful reminders that have convinced NGOs of the necessity to address the whole nuclear chain. To do this, emphasis will be on people especially those who have been affected by nuclear weapons, uranium mining, nuclear exports, nuclear power and nuclear waste; as well as those who are working to disrupt this lacerating chain. The participating organisations are collecting [testimonies](#) of affected people and making these testimonies available to a broad audience in the hope of drawing a human face on the often abstract debate on nuclear issues.

Biosecurity for Everyone: Meeting of Experts Biological and Toxin Weapons

The Chairman of the Meeting of Experts and the Meeting of States Parties to the Biological and Toxin Weapons Convention in 2012 has given NGOs the opportunity to make statements at the Meeting of Experts that took place in Geneva from July 16-21, 2012. On 16 July 2012, Enrique Sierra, delegate of Pax Christi International at the United Nations, presented a submission entitled "Biosecurity for Everyone." Pax Christi International strongly believes that international treaties including the BTWC are valuable instruments for protecting human life and dignity anywhere in the world. Rio +20 Brasil

Via Campesina – a global network conformed by institutions and individuals who fight for land rights and the Pastoral Land Commission, CPT, a Pax Christi International member organisation in Brazil, produced a statement in the People's Summit and the Rio+20 Conference. According to the

statement, 'the Conference failed because of the lack of commitment on what was proposed 20 years ago'. "Green economy" intends to marketing life, they said. On the other side, social movements met together in the People's Summit to reflect, debate and propose alternatives and new alliances to resist and promote knowledge about alternatives for a new world order.

Water shortages in Camp Liberty, Iraq

A letter dated 20 July 2012 addressed to Ban Ki-moon, Secretary General of the United Nations, has been forwarded by Marie Dennis, Co-President of Pax Christi International, concerning water shortages in Camp Liberty, Iraq. Pax Christi International has learned that 2000 Ashraf residents have been transferred to Camp Liberty, yet infrastructure that meets humanitarian standards, particularly the water system, has not been provided. Water shortages have resulted in a dreadful situation for the residents of the camp, who are using their own water tankers to bring water from an outlet 2Km from the camp. Pax Christi International requests that the Secretary General urgently interfere in this vital and humanitarian matter to urge the Government of Iraq to connect Camp Liberty to the Baghdad water network as soon as possible according to its promise and with the funding of the residents. Living Differences Allows Space for Peace to Grow

On July 13, 2012, Mark Barwick of the Pax Christi International Secretariat participated in a consultation on European policy on religious diversity and discrimination. The event was organised by a Jewish Contribution to an Inclusive Europe (CEJI), which conducts anti-discrimination training in many European countries through its programme called 'Belieforama.'

Belieforama addresses social conflicts through training and facilitation that seek to transform the way that diversity of religion and belief is experienced in society. The organisation has recently concluded a major survey of training participants to assess the training's wider impact on communities and society in Europe. The findings of this study will be presented later this year at a policy brief in Brussels.

Theme for '13 Peace Day Drawn From Beatitudes

Pope Benedict XVI chose "Blessed are the Peacemakers" as the theme for the 46th World Day of Peace, to be celebrated 1 January 2013. In a statement, the Pontifical Council for Justice and Peace announced the theme and noted that the papal message for the day will include the topic of religious freedom. "The annual message of the Pope, in the complexity of the present time, will encourage everyone to take responsibility with regard to peace-building."

"The Message will embrace, therefore, the fullness and diversity of the concept of peace, starting from the human being: inner peace and outer peace; then, highlighting the anthropological emergency, the nature and incidence of nihilism; and, at the same time, fundamental rights, in the first place freedom of conscience, freedom of expression, freedom of religion. The Message will offer, as well, an ethical reflection on some measures the world is going to take to contain the financial and economic crisis, the educational crisis, the crisis of the institutions and politics, which is also - in many cases - a worrying crisis of democracy.

The Message will also look at the 50th Anniversary of Vatican Council II and of the Encyclical Letter by Pope John XXIII, 'Pacem in Terris', according to which the primacy is always for human dignity and freedom, for the building of an earthly city to the service of every person, without any discrimination, and directed to the common good which is based on justice and true peace. Pax Christi International invites all its Member Organisations to work with the annual message for the World Day of Peace.
