## GENERAL

### Pax Christi International's New Logo

The Executive Committee of Pax Christi International has promoted an organizational development process since 2010. One of the core dynamics of this process has been to listen to the signs of the times and to revitalize their mission in current times.

As an expression of that development process, Pax Christi introduces the new logo of the global movement: a dove in the shape of a flame with a star in the centre. The peace at the heart of Pax Christi International is rooted in the Gospel and nurtured within the Catholic tradition. From this identity spreads the promotion of dialogue and close collaboration with other religious traditions as well as with non-religious actors from civil society around the world. In that way the movement shares its light like a beacon – the dove sits above the letter “I”, to form the shape of a candle. The peace at the heart of the movement also acknowledges diversity and addresses multidimensional challenges. The variations of colours within the dove represent the different ways in which Pax Christi works towards peace and advocates interconnectedness and fluidity. The typography – strong and contemporary, also reflects Pax Christi's commitment to peace in the present. Pax Christi invites you to see yourselves included in the

meaning of their new logo and welcomes you to use it when you refer to their worldwide network. ■

### Workshop on Extractives in Peru

On 13 October 2012, Martha Inés Romero met with the consultant from Peru who is in charge of the research on extractives. The workshop took place on the 25<sup>th</sup> and 26<sup>th</sup> October 2012 in San Mateo de Huanchor, 90 km from Lima. The meetings were attended by local authorities and community leaders. The research and conclusions of the workshop will result in a publication. A Nonviolence workshop took place from the 27<sup>th</sup> to the 29<sup>th</sup> of October 2012. ■

### Workshop on Nonviolence in Brazil

On 16 October 2012 Martha Inés Romero, Latin America & Caribbean Coordinator, travelled to Brazil to participate in a National Seminar organized by the Pastoral Land Commission, CPT, in Luiziana (near Brasilia). Martha Inés held a session presenting Pax Christi International's strategies and views on Nonviolence. She also attended the Board Meeting of CPT that took place on 20 – 21 October 2012. The topics on the agenda included – the fight for land and repression, challenges faced by peasants, Agro business without considering human dignity and food security among others. CPT is a Member Organisation of Pax Christi. ■

### Respect for Dignity and Rights in Haiti

The Commission Episcopale Nationale Justice et Paix, a Member Organisation in Haiti, published a report on respect for dignity and rights of individuals in the country. In the last 4 years, the Commission made observations on the situation of violence and on the violations of human rights. The Commission works with 300 local parochial commissions in the country. More than 150 of these commissions participated in the collection of facts and statistics. The report also contains analysis and recommendations. Read the report in [French](#). ■

## Pax Christi Montréal

On 27 August 2012, Antennes de paix / Pax Christi Montreal, held its Annual General Assembly. In 2013, Pax Christi Montréal will look forward to a new project celebrating the 50<sup>th</sup> Anniversary of the Encyclical 'Pacem in Terris'. The plan is to review how the issues raised in the Encyclical have been lived out in the Province of Quebec over the last 50 years and coordinate group discussions in Montreal using the document that will be produced. ## MIDDLE EAST

### Urgent Letter on Syria

Marie Dennis and Bishop Kevin Dowling, Co-Presidents, and José Henríquez, Secretary General of Pax Christi International have forwarded an urgent

letter on Syria addressed to Ban Ki-moon, Secretary General of the United Nations on the occasion of the General Assembly taking place in New York. The Movement has reiterated its rejection of violence, regardless of the source it originates from, and regrets the loss and disruption of so many innocent human lives. Although it seems hard to find solutions to the various problems that affect the region, we cannot resign ourselves to violence and to the aggravation of tensions. The commitment to dialogue and diplomacy must be a priority for all the parties concerned and must be supported by the international community. ### **[Pax Christi Australia's workshop on Syria](#)**

The September issue of Disarming Times, the Journal of Pax Christi Australia, featured two analysis presented in a workshop held in Australia by Dr. Fiona Hill and Joseph Wakim. The analysts gave an overview of the different positions and attitudes they believe Syrians have towards the conflict. Loyalists to President Bashar al-Assad, primarily Alawi Shia Muslims, fear persecution by the Free Syrian Army, while many Sunni Muslims are calling for a jihad against the Alawi-led government. Many Syrians are fed up with the corruption and the obstacles to professional advancement that they face, yet other Syrians are simply lost in

the middle – they want changes to occur, but they prefer the stability of having a government and believe that the new political parties being formed lack the ability to govern such a hostile state. Ultimately, many Syrians have come to believe that they are pawns in a much larger geo-political proxy war between Western powers and Russia and China. Read the [analysis](#).■

The uprising in Syria has gone on for 19 months and has culminated in a violent political crisis and humanitarian drama. So far, the international community have proven unable to help protect Syrian civilians or to find a solution to the conflict. Dutch peace organisation IKV Pax Christi advocates for placing the protection of civilians at the heart of any kind of action and in this context provides the EU with recommendations in its latest Syria Alert. The WSF organizers have also planned that Wiltrud Rösch-Metzler will participate and speak in a forum on a Nuclear Weapon Free Zone for the Middle East.■

## US religious leaders on US AID to Israel

Religious leaders representing many major faith groups in the USA have written a letter to Congress on 5 October 2012 seeking to make U.S. military aid to Israel contingent upon its government's "compliance with applicable U.S. laws and policies." The signers say they "have worked for decades to support both Israelis and Palestinians in their desire to live in peace and well-being" and "have witnessed the pain and suffering of Israelis as a result of Palestinian actions and of Palestinians as a result of Israeli actions." Kathy McKneely, acting director of the Maryknoll Office for Global Concerns, Member Organisation of Pax Christi International, co-signed the letter.■

## 10 years of the Arab Peace Initiative

This year commemorates 10 years since the Arab Peace Initiative (API) was launched by the Arab League Summit. IKV Pax Christi, representatives of Israeli and Palestine civil society organizations, Arab ambassadors and representatives of the European External Action Service, will provide an update about the Arab Peace Initiative. The seminar will place in Brussels on 22 November 2012. Fr. Paul Lansu from Pax Christi International will attend the event.■

## EUROPE

### Pax Christi Germany's General Meeting

The Annual General Assembly of Pax Christi Germany took place in Fulda from 26 – 28 October 2012. Among other topics, participants discussed the security and defence policies of the German government. A panel debate was also held on the role of churches in peace building. At the AGM, Members of the Commissions, the Vice President and Spiritual Adviser were elected. A farewell ceremony was held for Johannes Schnettler celebrating his invaluable contribution for 18 years as the Vice President and 21 years as member of the Board. José Henríquez and Fr. ## DISARMAMENT / DEMILITARISATION

### New report on Depleted Uranium

IKV Pax Christi Netherlands and the International Coalition for Banning Uranium Weapons (ICBUW) published a

new policy report on Depleted Uranium: "Hazard Aware: Lessons learned from military field manuals on depleted uranium and how to move forward for civilian protection norms." Pax Christi International is member of the ICBUW.

Hazard Aware analyses the precautionary measures adopted by militaries to reduce their troops' exposure to DU munitions and asks whether these could form the basis for civilian protection norms. The report was inspired by ICBUW's continuing precautionary discourse on DU. Hazard Aware is the first of three reports examining civilian protection, precaution and the acceptability of DU weapons. ## Abolition 2000 Strategy Session

A strategy session of Abolition 2000 took place on 11 October 2012 in New York. The aim of the session was to achieve a global treaty abolishing nuclear weapons. Majority of people and countries support a global treaty to abolish nuclear weapons, yet there still seems to be no negotiations for such a treaty. The aim is to get a Nuclear Weapons Convention. The session was chaired by Susi Snyder of IKV Pax Christi Netherlands. Beth Begley, Representative of Pax Christi International, and Alexandra Hiniker of IKV Pax Christi also attended.■

## CTBTO's interview with Susi Snyder

The Preparatory Commission for the Comprehensive Nuclear Test Ban Treaty Organisation (CTBTO) interviewed Susi Snyder of IKV Pax Christi Netherlands. For 15 years, Susi Snyder has been actively involved as a civil society advocate on issues such as sustainable development, human rights and nuclear disarmament. For five years Snyder served as the Secretary General of the Women's International League for Peace and Freedom (WILPF) based in Geneva before taking up her post with IKV Pax Christi in the Netherlands in 2010. Talking to [CTBTO Faces: People who define the Nuclear Age](#) during the May 2012 Preparatory Committee for the Nuclear Non-Proliferation Treaty Review Conference, Snyder shared her thoughts on topics such as the role of NGOs and citizens' networks in efforts to achieve a world free of nuclear weapons and testing.■

### First Committee UN General Assembly

Disarmament and International Security have been on the agenda of the 1<sup>st</sup> Committee of the UN General Assembly taking place in New York from 8 October – 9 November 2012. Pax Christi International had a strong delegation present. In addition to Beth Begley, Main Representative of Pax Christi International are two delegates from Pax Christi Ireland; six delegates from IKV Pax Christi Netherlands and four from the International Coalition to Ban Uranium Weapons (of which Pax Christi International is a member) attended. One Dutch colleague also attended the interim commission on Armed Violence Prevention and Reduction (a global network that is being set up by 10 organizations worldwide) and related meetings.■

### NGO Conference at UNESCO

The International Conference of NGOs at UNESCO in Paris will have its annual meeting from 12 – 14 December 2012. The topic of the gathering is "Culture and Cultures: Reconciling Universality and Diversity." There will be also a statutory agenda with elections and other business. Colette Petit and Alain

### 50th Anniversary Pacem in Terris

Making Peace is a major photographic exhibition that presents the international peace movement in its broadest sense and how people and organisations have shaped and influenced the course

of the 20th century. The International Peace Bureau (IPB), of which Pax Christi International is a member, produces this exhibition. Despite two World Wars and many bloody conflicts, there have been significant triumphs, such as the end of the Cold War and the apartheid regime, the banning of antipersonnel landmines and the creation of the International Criminal Court (ICC) - all of which were in large part the result of civil society efforts.
