[Pax Christi International Regional Workshop for the Middle East](#)

Pax Christi International is planning a regional workshop for the Middle East in Amman, Jordan, from 12 – 14 December 2012. The theme of the workshop is “Deepening Partnerships for Peace in the Middle East in the Context of the Arab Spring.” The workshop will discuss the best practices and lessons learned from the Spring Revolutions and reflect on Living our Differences: Confronting Violence and Diversity. A session on international advocacy and strengthening the network in the region is also part of the agenda. On 12 December, participants will visit refugees from Syria and Iraq and meet with leaders from different religions and churches. Participants are from Jordan, Palestine, Lebanon, Syria, Egypt, Iraq, Netherlands, Germany, Austria, United Kingdom, Belgium, Italy, Croatia, USA and India. On 15 – 16 December, Marie Dennis, Co-President, and José Henriquez, Secretary General will travel to Jerusalem to meet with H.B. Michel Sabbah, former President of Pax Christi International, and Israeli peace and human rights activists. ■

The European Network for Central Africa (EurAc) and its member organisations including Pax Christi International, welcomed the European Union's condemnation, after the meeting of the Foreign Affairs Council on 19 November 2012, of the M23 rebel group and other

rebel groups responsible for the serious deterioration of the security situation in North Kivu. The EU expressed its desire to support the creation of both an African Union Special Envoy and a United Nations Special Representative, with the latter having to facilitate regional dialogue. AMERICAS AND CARIBBEAN

[The Danger of Drones and Remote Control Warfare](#)

On 16 November 2012, Pax Christi USA members gathered for the annual School of the Americas Vigil and Action in Columbus. The programme included prayer, music, inspiring speakers and more. The event was open to the general public and was entitled: [The Danger of Drones and Remote Control Warfare](#).

The CIA and U.S. armed forces have used drones – unmanned aerial devices – for surveillance, bombings, and assassinations in Pakistan and in the war in Afghanistan. These devices perform combat missions in these countries while being flown by those who are far removed from the realities on the ground. The drone attacks have devastating consequences for the citizens of Afghanistan and Pakistan. Although exact figures on casualties are impossible due to the secrecy of the programme, the strikes have

dramatically increased since President Obama took office. Estimates are that for every militant target killed, 10 innocent people have died. These deaths are having an adverse effect: rather than making people feel more secure, they fuel anti-American sentiments and help recruiters of terrorist groups. ■

MIDDLE EAST

Christian Development and Peace Groups Call on Europe to Act Urgently Against Escalation of Gaza Violence

Three international Christian development and peace groups called on the EU and its Member States to use their influence for a ceasefire in Gaza and Southern Israel, where escalating violence was once again putting civilians at risk. Four years after "Operation Cast Lead," Israel engaged in a new military operation against Gaza, following the Israeli air force's assassination of a Hamas leader and the firing of rockets into southern Israel by Gaza militants. The APRODEV network of development organisations related to the World Council of Churches, the CIDSE alliance of Catholic development agencies, and Pax Christi International, issued a joint press release on 19 November 2012, which is available in [English](#) and [German](#). ■

Stop the Killings!

Several Member Organisations of Pax Christi International expressed their concern about the on-going violence in Gaza and the South of Israel. EAPPI's 10th Anniversary

To 10th anniversary of the Ecumenical Accompaniment Programme in Palestine & Israel (EAPPI) was celebrated with an ecumenical service followed by a photo exhibition. In the last 10-years, the EAPPI brought 1000 Ecumenical Accompaniers from 25 countries to support Palestinians and Israelis working for justice and peace. Pax Christi International assisted in the creation of EAPPI in 2002 and several individuals from Pax Christi Member Organisations participated in the programme. Christian Community Leaders Urge EU to Support Palestinian UN Membership

100 Christian community leaders in Palestine issued a statement declaring the Israeli occupation of Palestine a sin against God and humanity. They believe that ending Israeli occupation is the "only way for Palestinians, Christians, and Muslim to enjoy a life of prosperity and progress." The Christian community leaders believe that the Palestine Liberation Organisation's initiative to promote Palestine to an Observer State in the UN will get Palestine one step closer to freedom from Israeli occupation. Pax Christi International calls for more effective action against settlements

Since 1967, Israel has occupied Palestinian territories and has committed gross violations of human rights and humanitarian law. Pax Christi International supports the call of the United Nations Special Rapporteur Richard Falk for a boycott of Israeli settlement products, as well as of international businesses that profit from settlements on Palestinian lands, until the enterprises bring their operations up to par with international human rights standards and humanitarian law. Call for Palestinian Support from Pax Christi Australia

Since 1967, Israel has Pax Christi Australia sent a letter to Australian Senator Bob Carr to share its concern about the unequivocal support given to Israel by the Australian government. Pax Christi Australia calls for the government to condemn the recent Israeli actions against Palestinians in Gaza. They are concerned that the government is giving Australians the impression that Israel is the innocent victim of Hamas' rockets, when in reality the attack was sparked by the assassination of Ahmed al Jabari. Statement by Christian and Church Leaders on the Situation in Gaza

The National Coalition of Christian Organisations in Palestine issued a statement on the situation in Gaza on the 19th of November. The statement appeals to those supportive of peace to work with their governments and citizens to stop the destruction in Gaza.

The statement also shares the belief that the cause of the violence is the continuing Israeli occupation and the restrictions imposed by the Israeli authorities in the Gaza Strip. Among the signatories are H.B. Michel Sabbah, former President of Pax Christi International, and the Arab Educational Institute, a Member Organization of Pax Christi International in Palestine. Response to Pax Christi International on Syria from UN Secretary General, Ban Ki-moon

Last month, Pax Christi International sent a [letter](#) to the Secretary General of the UN, Ban Ki-moon, rejecting violence within Syria and reiterating the importance of dialogue in peace processes. In a letter of response addressed to the Co-Presidents and Secretary General of Pax Christi International, His Excellency Ban Ki-moon highlighted the plight of civilians in Syria and mentioned the urgent need to find a political solution to this crisis. Syria Forms a National Coalition of Opposition Forces

On 10 November 2012, the various factions within the opposition in Syria formed the Syrian National Coalition for the Forces of the Opposition and the Revolution. In a statement, IKV Pax Christi said this was a crucial step towards unification of the rebel forces

and is what foreign powers have been waiting for. It is of the utmost importance that this coalition gains the respect and recognition of the international community. The EU, and other powers, can no longer take issue with the divisions within the Syrian revolution. There is now hope and security for the Syrian people. How to Protect Civilians in Syria?

On 5 December 2012, the European Union office of the Heinrich-Böll-Stiftung together with IKV Pax Christi Netherlands organised a closed workshop titled "The Responsibility to Protect in Syria - What Can the European Union Do?" Invitees included representatives from the European Union Action Service, the European parliament, as well as NGOs and think tanks who deal with the issue. EUROPE

IKV Pax Christi Netherlands held a "BalkanBorrel," organized in cooperation with Our Future Network and with the Dutch United Nations Student Association that took place on 29 November 2012 in Utrecht. DISARMAMENT / DEMILITARISATION

First Committee UN General Assembly

Pax Christi International co-signed several statements of NGOs and civil society before the First Committee of the General Assembly of the United Nations which took place at the end of October 2012. The statements were on: Disarmament Machinery, Preventing a Humanitarian Catastrophe, and Outer Space Security. Pax Christi International was well represented at the First Committee with delegates from Ireland, the Netherlands, and New York. ■

Preventing a Humanitarian Catastrophe

Since the first nuclear bombing during World War II in Hiroshima and Nagasaki, the effects of nuclear weapons on societies have been clear. We are constantly reminded that nuclear abolition is of the utmost importance in order to guarantee a guaranteed human existence. Outlawing these weapons is the only insurance against their use. Disarmament Machinery

Both civil society and governments alike have warned that using a strict interpretation of the UN's consensus rule has damaged disarmament machinery within the UN. Outer space has become increasingly of interest to nations around the world. There are numerous governance challenges that have emerged since the adoption of the 1967 Outer Space Treaty. Currently, there are approximately one thousand satellites in space that are providing social, scientific, and economic benefits to people across the globe. Breaking the Nuclear Chain: From Victim to Actor

On 22 October 2012, IKV Pax Christi Netherlands joined the Global Partnership for Armed Conflict and Peace Boat in New York to launch "Breaking the Nuclear Chain," a new global campaign to prevent the looming humanitarian catastrophe stimulated by the nuclear chain. Nearly

100 representatives from embassies, United Nations agencies, and non-governmental organizations attended the event to learn more about the potential humanitarian disaster of the nuclear chain – from uranium mining, to power, to weapons, to nuclear waste – and what they can do to help prevent it. The campaign collects and shares the experiences of people who have been affected by the nuclear chain, and highlights how they are working to break it. Pre-Assembly Nuclear Advocacy Consultation

The WCC is organizing a consultation to inform and guide international nuclear advocacy and engagement with national and regional partners. Kevin McBride, Board member of Pax Christi International, will participate at the consultation taking place from 10–12 December 2012 in Seoul, South Korea. The consultation is being held in preparation for the World Council of Churches Assembly that is to be held in Busan, South Korea in November of next year. ■

Interfaith Network on Nuclear Disarmament in Japan

During the second week of December 2012, Sr. Filo Hirota, member of the Board of Pax Christi International, will be part of the International Conference on "nuclear disarmament" in Japan organized by the interfaith peace network. Nick Mele from Pax Christi USA will also attend the event. As colleagues in Japan continue renewing their commitment to a world without nuclear weapons, their commitment now includes the abolition of Nuclear power plants in a more conscious manner. ■

London School Students at Downing Street to Plea for a Nuclear Weapon Free World

A group of students from Maria Fidelis School in London wore colourful paper cranes, a symbol of peace and good health in Japan, and delivered a letter to David Cameron, Prime Minister of the United Kingdom, urging him to abolish nuclear weapons. This action was organised by the International Campaign to Abolish Nuclear Weapons (ICAN) and Pax Christi UK. It was part of an international project initiated by young people in Hiroshima, Japan. ATT Final Conference March 2012

Pax Christi International has given serious consideration to different perspectives on this issue and is persuaded that the use of these armed unmanned vehicles as weapons should be prohibited. Intervention on Poverty and Climate Change at the UN Commission for Social Development

Pax Christi International endorsed a statement to be submitted before the UN Commission for Social Development taking place from 6–15 February 2013. The focus is on poverty and climate change. The majority of the adverse effects of climate change will disproportionately impact those living in poverty throughout the world. Their increased vulnerability due to poor infrastructure and little or no funding for adaptation or mitigation will lead to greater hunger, disease and malnutrition. Climate change will negate the gains made through the Millennium Development Goals and inhibit the empowerment of people in achieving poverty eradication, social integration and full employment and decent work for all. Economic Crisis and Investment in Armaments
